# **POSITIVE TRENDS**

Domestic violence bills have been making their way through legislatures across the country in recent days. Legislators in South Carolina have sent SB 3 to Governor Nikki Haley for her signature. The bill would restrict access to firearms by domestic abusers for varying lengths of time depending on the severity of the crimes committed.

Nevada SB 175, which would prohibit a domestic violence misdemeanant from owning or possessing a firearm, has been sent to Governor Sandoval for his signature. The bill also contains numerous negative provisions (discussed in the Negative Trends section below).

Oregon's SB 525, which would prohibit firearm possession by domestic violence misdemeanants and the subjects of orders of protection, passed the Senate on May 21.

A domestic violence bill is pending in Connecticut and two additional domestic violence bills, New Jersey AB 4218 and Delaware SB 83, have been set for hearings on June 1 and June 10 respectively.

Last week, a bill to allow concealed carry without a permit and a bill that would have expanded concealed carry reciprocity died in South Carolina. Lawmakers did not act on a campus carry bill introduced earlier this year, and the South Carolina legislature adjourns this week.

# **NEGATIVE TRENDS**

As mentioned above, Nevada legislators have sent SB 175 to Governor Sandoval. **Despite the positive domestic violence provision mentioned above, the bill is primarily made up of provisions that would weaken firearms regulation.** The bill expands the state's stand your ground law, ends firearm registration in Clark County, and expands recognition of out-of-state concealed carry permits. Fortunately, prior to final passage, an attempt to add a campus carry provision to the bill failed. A new campus carry bill, AB 487, was introduced as an emergency measure in the Assembly on May 22 and has passed the Assembly.

In Texas, two gun lobby bills, SB 11, which allows campus carry, and HB 910, which allows firearms to be carried openly, have been the subject of much debate in the past several months. The bills have been somewhat watered down compared to their original versions. Both bills have now been sent to Governor Greg Abbott who is expected to sign both measures. Notably, Texas is the only state of the 15 that introduced campus carry legislation this year to move a bill through both chambers, despite the gun lobby's concerted focus on campus carry this year.

Maine's LD 652/SB245, which would allow concealed carry without a permit, passed the Senate last week. A vote in the House is expected as early as this week and it appears that Governor LePage supports the measure.

# **BILLS TO WATCH**

The Law Center, along with other national and state activists, continues to closely monitor North Carolina HB 562. This gun lobby bill would repeal the requirement to pass a background check and obtain a permit prior to purchasing a handgun, restrict health care provider communication with patients regarding firearms, and allow stalking misdemeanants to obtain a CCW permit after three years, among other dangerous provisions. The bill has passed the House and is currently in the Senate Rules Committee. The North Carolina Sheriffs' Association publicly opposes the bill.
