## 10 YEARS OF IMPACT


Ten years ago, a gunman murdered 20 children and six adults at Sandy Hook Elementary. Heartbroken and outraged, two years into her own recovery journey after being shot, former Congresswoman Gabby Giffords decided to channel her pain into purpose. Gabby founded the organization today known as Giffords, which has spent the past decade changing hearts, minds, and laws.

YEARS

Over the last ten years, Giffords has helped pass more than 525 gun safety laws in states across the country. This summer, we helped pass the Bipartisan Safer Communities Act, the fist federal gun safety law in nearly 30 years. We elected gun safety champions up and down the ballot—including the first presidential ticket to run on gun safety. We've challenged the gun lobby in court and defended lifesaving gun laws. And we're just getting started.





Ten years ago, gun safety was still a political third rail. Many people didn't think federal progress on this issue was possible. Despite the headwinds we've faced, we've succeeded in passing lifesaving gun safety laws, weakening the gun lobby, and making gun violence prevention a kitchen table topic in homes around the country. We've built a movement comprised of medical professionals, responsible gun owners, students, and survivors. Inspired by the courage of our founder, Gabby Giffords, we have dared to imagine a future free from violence—and worked to make that future a reality.

## **CHANGING LAWS**



Legislation:	<ul> <li>More than 525 gun safety laws passed in nearly every state in the nation</li> <li>Over 10,000 bills drafted and analyzed</li> <li>Over 50,000 hours spent lobbying across Congress and more than 30 states</li> </ul>
Litigation:	<ul> <li>Sued the NRA for campaign finance violations</li> <li>Sued ATF to force it to address ghost guns</li> <li>Filed more than 100 amicus briefs defending more than three dozen local, state, and federal gun laws</li> </ul>

We've accomplished so much together, but we still have a long ways to go. Gun violence has been on the rise in recent years, and a divided Congress makes further federal progress less likely—but not impossible. Together, we can build on our accomplishments over the past decade and build a country where no American lives in fear of gun violence.
